Patriot Karate Summer Camp – Consent, Release, and Acknowledgement

- 1. WAIVER & RELEASE: Physical Injury:** I understand that campers are engaging in physical activity/exercise, along with the use of Patriot Karate’s facility, equipment, training and instruction, which can be dangerous and could cause injury, and I assume all risk of injuries to my child, and hereby waive and release any claim or right to sue Patriot Karate, its employees, or agents for injury. I understand I should consult my child’s physician before undertaking any physical activity/exercise program, particularly karate activities. COVID-19 Waiver: I understand there is an inherent risk in contracting infectious diseases, including COVID-19, by participating in activities at Patriot Karate, and I assume that risk and waive any right to make a claim against Patriot Karate or its agents or employees if I suspect my child has contracted COVID-19 while attending Patriot Karate activities. Photography consent and waiver: I agree that Patriot Karate may occasionally take photographs or videos of students involved in our activities and may post them from time to time on its website, brochures, or on social-media services such as Twitter, Facebook, or Instagram, and I consent to Patriot Karate’s use of such images. I have carefully read this waiver & release and fully understand that it releases Patriot Karate of all liabilities for any injury I might claim relating to the items listed above.
- 2. LOSS/DAMAGE/THEFT:** I understand Patriot Karate does not assume any responsibility for the loss, damage or theft of any property belonging to the campers and students, and I agree not to make any claim for loss or damage against Patriot Karate, its agents, or employees.
- 3. CAMPER DISCIPLINE POLICY.** I understand that, to provide my child and other campers with a safe and fun experience, Patriot Karate expects all campers to exhibit proper behavior, self-discipline, and self-control. If my child cannot be controlled by verbal commands, or is a constant disciplinary problem, I acknowledge that, in Patriot Karate’s discretion, he or she may be suspended from the camp and may not be permitted to return to any following camps.
- 4. EMERGENCY MEDICAL TREATMENT.** I give my consent to Patriot Karate, its officers, agents, employees, or any emergency medical personnel to administer necessary treatment to my child in the event of an emergency and authorize transportation for my child by ambulance if necessary. I agree to assume responsibility for payment of the emergency treatment.
- 5. FOOD AND SNACKS.** I acknowledge that Patriot Karate will **not** provide food and snacks during camps, and it is my responsibility to send my child each day with lunch and snacks. Patriot Karate recommends two snacks, lunch, and a water bottle or other drink container.
- 6. MINIMUM AGE.** I affirm that my child will be at least 5 years old on the first day of any camp attended.
- 7. CANCELLATIONS/CHANGES.** I understand that requests for cancellations or changes must be communicated in writing by filling out a Cancellation/Change Form at the front desk, or by adequately describing the request in an email to PatriotKarate@gmail.com , and Patriot Karate is not responsible for any change requests communicated in any other way.
- 8. LATE PICK-UP FEE.** I understand that Patriot Karate is not staffed to supervise campers past 6:30 pm, and all campers **MUST** be picked up by that time, and I agree to pay a \$15 late fee (per camper) for any pickup past 6:30 pm, plus an additional \$15 late fee for each additional quarter hour.
- 9. EXEMPTION FROM LICENSURE.** I acknowledge Patriot Karate is not a licensed day care facility. This summer camp program is not required to be licensed by the Georgia Department of Early Care and Learning as it is exempt from the state licensure requirements. Exemption number: EX-49607.
