## Patriot Karate Summer Camp - Consent, Release, and Acknowledgement

- 1. - 3. **CAMPER DISCIPLINE POLICY**. I understand that, to provide my child and other campers with a safe and fun experience, Patriot Karate expects all campers to exhibit proper behavior, self-discipline, and self-control. If my child cannot be controlled by verbal commands, or is a constant disciplinary problem, I acknowledge that, in Patriot Karate's discretion, he or she may be suspended from the camp and may not be permitted to return to any following camps.
